Dues: After completing the race schedule, the club voted to retain dues at the existing annual rate of \$10.00

Grand Prix & Dinner: The meeting then turned to the Onion River Sports Grand Prix and Volunteer Awards Dinner to be held on Thursday March 8 at 6:30 P. M,. at the Montpelier Methodist Church on Main Street. Norm agreed to contact Onion River Sports to arrange for awards to be presented to Grand Prix winners, possibly specially engraved mugs. Norm's discussions with Onion River personnel will also include the continuation of the Grand Prix in 2001. Tim Noonan will serve as master of ceremonies at the dinner.

Singlets: Because the manufacturer of the CVR singlets, which had a cooperative arrangement with the Road Runners Club of America, has ceased operations, Norm will continue to investigate a new source for the shirts.

Other Upcoming Events: The Green Mountain Athletic Association will hold its annual meeting on February 3 in South Burlington and the Lake Winnipesaukee Relay will occur on Saturday September 22, 2000.

Bylaws Changes: Norm proposed changes in the annual election calendar and membership year to correspond with the running season. As a result, the club officers elected in January 2001 would serve until March 2002. Beginning in 2002, the club will elect new officers each March. Donna suggested merely changing the membership year and not amending the bylaws. Norm moved that the bylaws be amended to reflect the membership year and new calendar for election terms. The motion was approved. Michael then moved that an updated revision of the bylaws be typed and that the revision reflect all changes that have been made to the bylaws which the membership approved.

Leaf Peepers: Norm proposed expanding Curtis Picard's role in the management of Leaf Peepers. Norm moved that the Leaf Peeper Committee be authorized to negotiate with Curtis regarding the terms for a salary increase. In addition to a salary raise, Curtis would be awarded a percentage of additional sponsorship income. This proposed arrangement would significantly reduce the role of the Leaf Peeper Committee. Tim suggested that the Leaf Peeper Half-Marathon be capped at 600 runners for safety and logistical management reasons. Tim's recommendation was approved.

Race /Meeting Calendars: Richard requested that each race director develop a calendar for their respective races. Copies would be made available to the membership. Richard further requested a year long calendar of CVR meetings. As an alternative, Norm suggested, as an alternative, that the club schedule two meetings ahead. Adopting this policy, the next two CVR business meetings were scheduled for Wednesday April 4 at Dave's and Laura's and on Wednesday May 2 at Darragh's. Both at 6:30 P.M.

National Life & Fun Run: National Life Insurance has contacted Tim regarding participation in Fun Runs. Tim will speak with the National Life staff and suggest that the company supply a volunteer to record their employees' times

Adjournment: Michael moved that the meeting adjourn at 6:05 P.M. which was approved.

### Business Meeting April 4, 2001

The club held a regular business meeting on Wednesday April 4, at the home of Dave Kissner and Laura Medalie in East Montpelier. The meeting opened with acceptance of the secretary's report of the January 12, 2001 CVR Annual Meeting, and an acceptance of the treasurer's report. CVR Treasurer, Laura Medalie, summarized the club's finances reporting an approximate bank account balance of \$5,000.

Attention then turned to a review and updating of plans for this year's schedule of club sponsored races:

Mutt Strutt: The annual canine run at Little River State Park is scheduled for Sunday April 22. Codirector Donna Smyers urged that runners, accompanied by their own or a borrowed dog, participate in this first of the spring CVR race events. Jamie Shanley will once again serve as codirector. Donna also requested volunteers to assist. She announced that as a cost saving measure, there will not be a portable toilet on the site. The only concern expressed was that the remaining snow could prove problematic.

Kid's Track Meet: This annual community event is tentatively scheduled for Saturday June 2<sup>nd</sup>. However, the availability of the Montpelier High School athletic field is uncertain. While Tim will be confirming the field's status he recommended that as alternative date, possibly during the summer, be considered.

Capital Stampede: Race director Sam Davis will once again travel from Colchester to

assure that the Capital Stampede, to occur on Saturday June 9, is a run away success. The registration form, as of the meeting date, was set for printing, the first registrant had already entered, and the mailing list has been sent to Eric.

Paul Mailman 10 Miler: Dave Kissner will once again serve as race director for this June 24 event. He reported that all planning was on target.

Bear Swamp: Thursday June 12 is the evening for this year's event which in 2001 will serve as the concluding event of the triennial Hukamonk Swamp Challenge. series.. Tim Noonan will direct the annual trek along some of Middlesex's finest hills. Tim reports all is ready for this much anticipated race.

GMAA 25<sup>th</sup> Anniversary Relay/Party: On Saturday July 22,CVR will join the Green Mountain Athletic Association in helping our sister club celebrate its 25<sup>th</sup> anniversary.

Berlin Pond Run A Run: This annual 8k circumferential race at Berlin Pond is scheduled for Sunday August 5. Michael Chernick will once again direct race day activities. He reported that all was on course in preparation for this now redesigned individual race.

Northfield Savings Bank 5k/Kid's I Miler: Saturday September 1 is the date for the Northfield 5K. & Kid's 1 miler. The Northfield Saving's Bank's staff has already contacted past CVR members who have assisted in the technical aspects of this race. A planning meeting will occur in early May. Tim Noonan will serve as the technical race director. Granite State Racing Systems has been hired to once again provide race timing services.

Leaf Peepers: Scheduled for Sunday October 7, Leaf Peepers will again be under the direction of Curtis Picard. Curtis has accepted the club's offer of a \$1,200 fee, a substantial increase over last year, in exchange for assuming more of the race responsibilities. It is hoped that the Leaf Peeper Committee will not need to meet very often.

First Night This New Year's Eve event, under David Kissner's direction, will be run, not surprisingly on December 31.

Turning to other matters, Donna Smyers reported progress in updating the club's mailing list. The Onion River Sports Race series will be expanded to include both the Northfield 5k and Leaf Peepers. These additions will be for point counting purposes and Onion River Sports will not become a cosponsor at either event. There was discussion of redefining the volunteer criteria for race series participants. It was agreed that:

Participants must work at a CVR race during the year

A participant volunteering at a race will receive the average points that
he or she earned in other races.

Volunteering at Leaf Peepers would only earn credit for one race

CVR, through Norm Robinson, will work with Onion River Sports on several topics including the volunteer criteria, the \$200 cash disbursement to the club from last year's race series and the development of a membership card that will be good for discounts at Onion River Sports. Norm reported that replacing the CVR singlet with another identical shirt which includes the red edging may be impossible. The replacement singlet, therefore, may be slightly different than the current shirt. Club President Richard Cleveland and Norm will work to develop a unified and current e-mail list. Richard will also check with Mack Gardner-Morse regarding club publicity. The next CVR meeting is scheduled for Wednesday May 2 at Darragh Ellerson's home at 6:30 P.M. The June meeting will be at Michael Chernick's residence on Wednesday June 6 at 6:30 P.M.
