


THERE'S MORE OF US!

After a period of declining numbers of runners and racers, maybe things are looking up. The CVR-sponsored Run for the Health of It 5k had more runners and walkers than last year and the State Agency Race/Corporate Cup Challenge showed a dramatic increase in runners and walkers this year. Also, the Burlington Marathon and Marathon Relay has attracted a great deal of interest.

A positive sign of an upward trend is the number of CVR members. Currently, we have 93 members whom have paid dues for 1989. This is way above where we were last year at this time and, in fact, represents more members than we had at the end of 1988. MINUTES - April 24, 1989 meeting held at Norm Robinson's house. Potluck supper.

Present: Norm, Darragh Ellerson, Nancy Maloney, Bob Howe, Tim Noonan, Bob Murphy, Ceoff Lindemer and Dot Helling.

First item of business was election of a new secretary. Merill Cray has had to resign because of professional commitments. Bob Howe will take over beginning next month.

Treasurer's Report: \$674.17 in the till. "Good for this time of year," says Tim. Norm also reported that there are now 75 members as the result of our membership drive. "Fabulous for this time of year," says Tim. Thanks are in order to our PR director Nancy Malouey for getting articles in the Times Argus and The World about the drive and to Norm and Tim for doing up the applicant forms and disbursing them. Norm also has volunteer listings from the applications broken down by race so call him, race directors, when you need help. We have a member signed up until 1992!

Fun Runs begin in two weeks, on May 2. Fun Runs will go forward as usual, beginning every Tuesday at 5:30 PM at the Liquor Control Warehouse at the foot of the bike path. We have coordinators for May and June. Still need a coordinator for July. Dot and Geoff will share August. Darragh is the May coordinator so talk to her if you can help. Change of format has been tabled until we see this year's response and participoation level.

Tim did a mailing of Capital City Stampede, Ten Miler and the U32/5K race forms along with membership applications. Members got them in the last news-letter which, by the way, also reminds you if you haven't paid your 1989 dues. (If not, pay up soon or you won't get another newsletter.) Tim will be doing another mailing in mid-July for Berlin Pond, Leafpeepers and Juniper Hill. Race directors should get him their applications by July 1 to be included in the mailing.

RACE REPORTS: 1. U32 is May 13, just around the corner. Race director Larry Miller wasn't here so we coildn't get a report although we know the advertising is out. Tim spoke to Larry and thinks everything is "going fine." Alas, the posters say this course is certified which it is not. Take heed, race directors, this is a booboo that does not go unnoticed. 2. Montpelier Ten Miler (June 24) - Tim reported that we almost lost Athletic Attic as a sponsor but, thanks to Larry Cruz, they're in for 1989. Tim also said he expects attendance will be up this year. 3. Leafpeepers (October 1) -Darrash met with WDEV regarding some format changes for this year. For one, they are looking to replace the Lions Club which pulled out this year with the High School Boosters Club. The Boosters have personed the water stops in past years. They are also considering using a local milk operation like Booth Brothers instead of going statewide with Milk again. Leafpeepers has been written up in the June 1989 Running Times magazine in its Fall Guide to Marathons and Half Marathons. A gold mine of advertising which, alone, should raise participation. Darragh will be sure to present WDEV with a copy. 4. State Amency 5K takes place May 18. CVR is not a sponsor, although members are asked to help. Bob Murphy reported that this year the State has hired Granite State Racing System to do the finish line results for \$175. He suggested it's something for us to take a look at for our future races. 5. Capital City - June 10 - Geoff reported things are on schedule and that Onion River Sports and State Street Market are the sponsors once again. We will have the same financial arrangement with them and things are "going fine." 6. Juniper Hill - Nov. 4 - Bpb Murphy has officially altered the distance from a 15K to a 12K for traffic control reasons. Otherwise, all goes smoothly. No report on Berlin Pond (August 5) or the Subultimate (Sept. 9). Remember, we are doing the Subultimate this year in conjunction with GMAA members. Yay, competition!

Norm want≶to have a club get-together at the Burlington City Marathon. Once again, we discussed the need for a July Fun Run Coordinator. Dot Graham, where are you??? We need you, and John can job-share.

The last item of business was to decide on the scholarships. Applications were down this year but all eligible schools, except Harwood, were represented. Bob Howe surmised that the schools may be preselecting. He knows there was good recognition of our scholarships in all the schools (Northfield, Spaulding, U32, Montpelier, Peoples' Academy and Harwood). Each of the seven (7) candidates we reviewed had extremely high qualifications. In fact, each one was fully qualified for the scholarship. The decisions were very tough. The winners of the 1989 CVR high school scholarships were for males Gregory Tosi of U32 and for women Gretchen Walthers of Northfield. Both students ranked at the very top of their class scholastically and are excellent runners. Both will be going on to college in the fall.
